## TAKING CARE OF YOUR BUCKBOOTZ FOOTWEAR

- **Regular Cleaning** will help you extend the life of the leather upper. Removing mud/other debris gently with a brush before wiping with warm water will aid the leather.
- **Allow the leather to dry out naturally**, using dry newspaper or kitchen roll inside the boots to assist. **Never harsh dry the leather!** Harsh drying will cause the leather to shrink, crack and go brittle. This condition cannot be reversed.
- Consider use of BUCKBOOTZ leather care products including leather gel and Beeswax spray to assist the nourishment and water resistance properties of the leather.

## COMFORT

- Consider the wear of a quality sock to provide your feet with comfort, cushioning and moisture wicking. BUCKBOOTZ SOKZ – COOL and CORDURA provide socks for all seasons and wear.

## DAMAGE
